2. **Spray string, stink bombs, laser lights, food or beverages will not be sold. Adult Entertainment merchandise will not be displayed or sold. This will result in removal by local Law Enforcement without refund.**
3. **Electric, water or sewer hook ups are not available.**
4. **YOU MUST HAVE A VALID OHIO VENDOR'S LICENSE.**
5. **The fee is \$35.00 for a 20'x20' space. No Refunds.**
6. **Quiet time starts at 11:00 pm.**
7. **Flea market spaces must have merchandise to be sold on the space.**
8. **TO GUARANTEE SPACES FOR 2025, SPACES MUST BE PAID FOR BY THE END OF THE FESTIVAL 2024. (3:00pm Sunday). This payment is nonrefundable.**
9. **The Luckey Fall Festival Association does not own the land the Festival is held on. Due to the potential of Basic Park renovations: If your space is not available, we will refund the money you have paid. Or, with your permission and approval, place you in a different space. The Association is not responsible for a loss of revenue in the event that your space and/or row changes.**
